

SNOWSEEKERS SKI TRIP REGISTRATION
June 1, 2010-May 31, 2011

Registration: Your name will be put on a trip(s) list after receipt of your initial nonrefundable deposit, completion of a membership form, waiver form, trip registration form, and your payment of club dues. When the fully completed forms, trip(s) deposit(s), and dues payments are received, you will be registered on a trip(s). When any of the trips are filled, an additional waiting list will be created. The completion of the proper forms, along with fully paid dues and trip payment(s) will be required to be put on a waiting list.

Payment Schedule: The balance due on trips (beginning with the September regular meeting) must be paid according to the published payment schedule, or earlier. Final payment is to be paid no later than the December regular meeting date, or earlier if the individual trip contract requires it. Anyone failing to make payments according to the published payment schedule is subject to being removed or replaced. Prior to being removed or replaced you will be contacted by phone or email and given seven (7) days to bring your payments up to date. If your up to date payments are not received during that time period, you may be removed and/or replaced by a member on the waiting list.

Waiting List: Your name will be placed on the waiting list only when up to date trip(s) deposits, dues, and the proper forms have been fully completed. Your deposit(s) will be held until you clear the waiting list and are registered on a trip(s). Your deposit will be applied in full toward any trip(s) for which you have registered. If selected to fill a vacancy on a trip(s), registration forms along with the required up to date deposit(s) will be due immediately. If you do not become registered for any trip(s), your deposit will be refunded in full.

The waiting list of people will be contacted in order of registration and deposits. If selected to fill a vacancy on a trip(s), registration forms along with the required up to date deposit(s) will be due immediately. If you cannot be contacted at your last known contact information (phone or e-mail), the next person on the list will be called. Once placed on the trip(s), the person(s) agree to assume the full responsibilities of the trip(s) arrangements.

Cancellation: To cancel from a trip(s) or the waiting list, you must send written notice to the Trip Coordinator. All cancellations will incur a charge for any unrecoverable costs incurred by Snowseekers Ski Club because of the cancellation. Membership: You must be a fully paid member of Snowseekers Ski Club, in good standing, to be a participant on a ski trip(s) or waiting list. A completed registration (membership, waiver, trip registration forms) with fully paid membership must be on record. No exceptions will be made. These registration requirements apply to all family members.

Travel Interruption Coverage: I acknowledge that I have received information about Trip Interruption Insurance. Your signature(s) below state that you have read, understand, and accept the trip registration requirements and information.

All signatures and full birthdates must match your name exactly as it is shown on the photo ID (Driver's License, Birth Certificate, or Passport) that you plan to use at Airport Security, and for your Airline tickets.
