I acknowledge that I am solely responsible for the condition of my own personal well being and health, lodging and rental equipment, baggage and personal effects.

In the event of storm, inclement weather, acts of God, vehicle malfunction or breakdown, strikes, work stoppages, or other causes of events beyond the control of Snowseekers Ski Club, Sports America Tours Inc., and Lamers Bus Lines, Inc., I shall pay and be responsible for all costs, charges and expenses arising out of but not limited to, charges imposed by carriers, lodging management, ski areas, equipment rental stores or otherwise.

I know that bare spots, variation in snow, stumps, forest growth, debris and rocks, and many other hazards or obstacles, marked or unmarked, exist within any ski area. I assume the dangers involved and waive Snowseekers Ski Club, Sports America Tours Inc., and Lamers Bus Lines, Inc. of any liability whatsoever for the conditions of the ski area.

I understand that Snowseeker group lift tickets are not to be sold or given to any person other than a Snowseeker member in good standing. No liability is assumed for anyone who does not abide by this rule. I also understand and agree that no discounted trip prices for airfare, ground transportation, or lift tickets will be available to anyone using any alternative lodging during the same time or in the same ski area of a scheduled Snowseekers ski trip unless the trip is filled and/or there are no penalties to be incurred by the Snowseekers Ski Club.

I acknowledge that skiing/snowboarding is a dangerous sport that can result in injury or death. The Snowseekers Ski Club recommends the use of safety equipment at all times. This includes, but is not limited to, helmets, goggles and proper skis/snowboards and bindings. Failure to use any recommended safety equipment is at my discretion. I, and my heirs, agree to indemnify and hold harmless Snowseekers Ski Club in the event of any accident, injury, or death as a result of my failure to use proper safety equipment.
