Cancellation Policy

If you must cancel your trip(s), the effective date of the cancellation will be upon notification in writing to Trip Coordinator, Stu Howes, 2619 Venetian Lane, Elgin, IL 60124. The cancellation charge will be the first two initial deposits (unless you find a suitable replacement) and any additional expenses incurred by the club.
