**2020 Western Ski Trip
Snowmass, Colorado
February 29 to March 7, 2020**

Registrations for the 2020 Snowmass, CO ski trip are now being accepted. A trip deposit and completion of the trip registration, waiver, and membership forms will be required to secure a place on the trip. The first of four equal deposits of the costs listed below will be needed along with the completed forms.

Your first trip deposit and completed forms are due in June. Your final trip payment must be received by October 8th. Visit the website www.Snowseekers.org to find the forms needed for registration. They are found under “Documents, Newsletters, and Forms”.

The maximum number of participants for this trip is thirty four (34). We already have 31 interested people on the waiting list. The trip spots will be filled on a first come basis. Please let me know if you are definitely planning on the Snowmass ski trip. This trip will fill up quickly.

PRE-EXISTING CONDITION EXCLUSION WAIVER

Pre-existing medical conditions are eligible for coverage when:

- Plan is purchased at or before final trip payment
- Full trip cost is insured
- The traveler is medically able to travel at the time of plan purchase

A pre-existing condition is an Injury, Sickness or other condition (excluding any condition from which death ensues) of an Insured, Traveling Companion, Business Partner or Family Member which, within the 60 day period immediately preceding and including the Insured's coverage effective date.

This exclusion applies to those not traveling.
